- •The Best Partnership category, created in 2006 as the first "people's choice" award in corporate citizenship, is dedicated to business-nonprofit collaborations that achieve high impact and sustainable results on social, community, or environmental issues. This year's finalists are: Caterpillar with the First Response Team of America; Hilton Worldwide with Global Soap Project; Intel with World Vision; Merck & Co. Inc. and General Mills with CARE; and WellPoint Foundation with Boys & Girls Clubs of America.

The winners in each category will be announced on December 6, 2012, at an event in Washington, D.C. Judging for the Business Neighbor and International Ambassador categories involves a peer committee with past award winners. The winner of the Corporate Steward category is selected by a panel of preeminent experts in corporate citizenship and business performance. The Partnership Award winner is selected through a public voting campaign on BCLC's website. Voting opened on Tuesday, September 18 and will run through Friday, November 2.
