Baxter's manufacturing facilities in Alathur and Waluj use coconut shells, rice husks and sugar cane remnants as energy sources in boilers, which decreases fossil-fuel related greenhouse gas emissions, reduces energy costs and contributes to the local economy.
- •Participating in Making a Meaningful Difference Month each October, an initiative that rallies employees to give back to their local communities. In 2011, more than 700 Baxter India employees and their families volunteered 2,500 hours to improve the lives of people in their communities and care for the environment.
- •Supporting AmeriCares, Save the Children and Plan International India with grants through The Baxter International Foundation, Baxter's philanthropic arm, to increase access to healthcare.

## 2012 Malta Ambassador's Environmental Excellence Award

Baxter was recently named the recipient of the 2012 Ambassador's Environmental Excellence Award by the U.S. Embassy in Malta. The Ambassador praised Baxter for its leadership in implementing and engaging the community in initiatives that benefit the environment.
