

For over a decade now, the Greek companies of Mellon have been maintaining a blood bank for the employees and their first degree relatives. Indicatively, during 2016, more than 90 bottles of blood were collected, 50 of which were used to meet the needs of Mellon's employees and their families.

Also, in Ukraine the sales personnel gave blood for the child hospital "Ohmodet" and in Serbia the employees gave blood for the Blood transfusion Institute.

During a period of four months, Mellon Poland has been collecting corks for the shelters Józefów and Pabianice. For each kilo of corks they collected, 3 meals were given to stray animals. In total, Mellon Poland collected 57kg corks! Mellon Bulgaria made a donation to International Women's Club Sofia and Mellon Romania helped a child who needed hearing aid.


Participation in Career Fair for People with Special Needs

- Mellon Serbia supports several organizations "Živimo zajedno" by recycling paper and cans and the Serbian Association of Paraplegics by recycling cups


